SHIPMENT WEIGHTS

Shipments should be adequately insured by the exhibitor for coverage when out of care, custody and control of BorderWorx.

BorderWorx will not be held responsible for concealed damage upon delivery to advance warehouse, or damage or loss of merchandise after delivery to booth, before or during installation time, or at conclusion of show prior to delivery to common carrier. BorderWorx will not be responsible for damages while handling loose or inadequately packed exhibit materials. The condition, count, and contents of the materials at the time of removal will be final and binding. BorderWorx reserves the right to alter the exhibitor's bill of lading to reflect the actual condition, count, and contents at the time of removal. BorderWorx will not be responsible for failure or delay in performing service when delay is caused by strike, labour stoppage or any other cause unavoidable or beyond BorderWorx' control.
